5. Details

- a. Description of the organisation:

Through our platform, we provide a place for data subjects and data holders to advertise their data to be shared, and for data users to search among advertised data files, select those they wish to possess and order them electronically.

- b. Data intermediation services provided:

In order to share data securely and transparently, registration is required to use the site, during which the parties are clearly identified by us. During registration, the data required for identification and contracting are collected, as well as the legal relationship between NIDHAS Data Intermediary Kft. (NIDHAS) and the person or organization registering takes place.

The public contents (samples, descriptions) of the data files offered for sharing, as well as the list of registered sellers can be accessed and browsed by anyone.

After registration, data subjects and data holders may advertise data sets offered for sharing, broken down by categories of data. Successful publication requires uploading a sample and specifying specific parameters for the file (e.g. specific data types within the file, format, source, legal status, use/processing restrictions, etc.). During publication, the data subject or data holder is obliged to declare the lawful possession of the data file and the existence of the right of disposal. In order to make the data available, the data subject or data holder accepts the documents establishing the legal relationship necessary for data sharing (General Terms and Conditions [GTC] / General Terms of Use [GTCU]).

Before ordering the advertised data set, the data user is obliged to establish a legal relationship necessary for data sharing by accepting the relevant provisions of the

GTC/GTCU. In order to place an order, it is also necessary to fill in a declaration of use and utilization, which becomes available to the data subject or data holder prior to the completion of the transaction.

NIDHAS does not participate in legal relations, the contract is concluded between the data subject or data holder and the data user.

After acceptance of the declaration of use and processing by the data subject or data holder, a secure transaction takes place (data transfer and payment).
